Hogback-Pennsylvanian (Gas Pool) Continued

This Pool was previously designated as an oil pool by Order No. R. 542-A

I now recommend that this pool be redesignated as a gas Pool for the following reasons:

1. A market has been developed for the non-combustible gas produced from this one well pool.
2. The G.O.R. of this well is 45,862 to 1. and has an I.P. of 6,650 MCFD.
3. The operator will produce only that amount of gas for which a market is available and the quantity of oil produced incidentally with this volume of gas will be utilized. Consequently, this will be no waste.
