ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 14, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 14th day of April 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Ballard-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool and the West Kutz-Pictured Cliffs Pool all in San Juan County, New Mexico, the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico and the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Ballard-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

TOWNSHIP 27 NORTH, RANGE 9 WEST, NMPM
N/2 and SW/4 Section 33
N/2 Section 34
NW/4 and SE/4 Section 35

(b) That the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

TOWNSHIP 25 NORTH, RANGE 5 WEST, NMPM

NE/4 Section 3
E/2 Section 23
W/2 Section 24
NW/4 Section 25

TOWNSHIP 26 NORTH, RANGE 5 WEST, NMPM

S/2 Section 31
E/2 Section 34

TOWNSHIP 27 NORTH, RANGE 9 WEST, NMPM

NE/4 Section 3

(c) That the Fulcher Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

TOWNSHIP 29 NORTH, RANGE 10 WEST, NMPM

E/2 Section 31

(d) That the West Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:

TOWNSHIP 28 NORTH, RANGE 13 WEST, NMPM

E/2 Section 36


(e) That the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:


