Southeastern New Mexico nomenclature case calling for the creation of new pools and the extension of existing pools in Lea, Chaves and Eddy Counties, New Mexico:

(a) Creation of a new oil pool for Devonian production, designated as the North Gladiola-Devonian pool, and described as:

(b) Extension of the Blinebry pool to include:

(d) Extension of the Grayburg-Keely pool to include:

(e) Extension of the Terry-Blinebry pool to include:

TOWNSHIP 20 SOUTH, RANGE 38 EAST
Section 34: NW/4

(f) Extension of the Townsend-Wolfcamp pool to include:

Section 36: N/2 & N/2 S/2

TRANSCRIPT OF HEARING

MR. GURLEY: 1070 is the Southeastern New Mexico nomenclature case calling for the creation of new pools and the extension of existing pools in Lea, Chaves and Eddy Counties, New Mexico.

MR. WALKER: Let the record show that Mr. Montgomery was sworn in for all the nomenclature cases.

R A N D A L L M O N T G O M E R Y

having been previously sworn, testified as follows:

DIRECT EXAMINATION

By MR. GURLEY:

Q Would you state your name, please?

A Randall Montgomery.

Q Are you the same Randall Montgomery that just testified in Case 1055?

A Yes, I am.

Q What is your position?

A Geologist, New Mexico Oil Conservation Commission.

Q In your official capacity, Mr. Montgomery, have you had opportunity to study the proposed creation of a new pool for North Gladiola-Devonian pool in Lea County, New Mexico?

A Yes, sir, I have.

Q Would you state to the Commission your conclusions and recommendations as a result of that study?

A I recommend that the pool, Northeast quarter, Township 12 South, Range 38 East, Section 6, --- the discovery well in the field was Ralph Lowe, U. U. Wallace No. 1 in Unit A of 6-12-38,

completed on 3/24/56 in the Devonian, top of the perforation, 12,010 feet. I recommend that the field be created as advertised.

Q Have you had an opportunity to study the proposed extension of the Blinebry Pool?

A Yes, sir, I have, and recommend that the pool be extended as advertised.

Q Have you also had an opportunity to study the proposed extension of the Caprock-Queen Pool?

A Yes, sir. I also recommend that that pool be extended as advertised.

Q Have you made a study of the proposed extension of the Grayburg-Keely Pool?

A Yes, sir, I have.

Q What have you decided?

A I recommend the pool be extended as advertised.

Q Have you had an opportunity to study the extension of the Terry-Blinebry?

A I have. I recommend that the pool be extended as advertised.

Q Have you had an opportunity to study the proposed extension of the Townsend-Wolfcamp pool?

A Yes, I have and I recommend that field be extended as advertised.

Q Do you wish to introduce any exhibits at this time?

A Yes, sir, I would like to submit the Exhibits 1 through 8, inclusive.

Q Were those exhibits prepared by you or under your direction?

A Yes, sir, that is correct.

Q Which?

A Under my direction.

Q Those exhibits were used in reaching the recommendation that you just submitted to the Commission?

A In part that is true, yes.

MR. GURLEY: I would like to introduce in evidence Exhibits 1 through 8.

MR. PORTER: Without objection they will be received.

MR. GURLEY: That is all.

MR. PORTER: We will take the case under advisement.

MR. NUTTER: I have a question before you do that. There was a question as to whether the extension of the Blinebry was the Blinebry gas or oil pool. That was the oil pool, is that right?

A The Blinebry Pool, yes, sir, that is the oil pool.

CROSS EXAMINATION

By MR. MANKIN:

Q Based on the Gulf well, was it not?

A That is correct.

MR. PORTER: Is that all.

MR. GURLEY: Yes.


MR. PORTER: We will take the case under advisement.
