Randle "A" No. 1, Blinebry Gas Pool

Gentlemen:

By this letter of application Amerada Petroleum Corporation wishes to state the following:

- (a) That Amerada Petroleum Corporation J.G. Randle "A" No. 1 located 1980 ft. FNL and 1980 ft. FWL of Section 20, Township 21-S, Range 37-E, Lea County, New Mexico was completed as a Blinebry gas well August 25, 1954.
- (b) That the applicant proposes to assign this well a non-standard gas proration unit consisting of 80 acres which is the SE/4 of NW/4 and the SW/4 of the NE/4 of Section 20, T-21-S, R-37-E, Lea County, New Mexico.
- (c) That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- (d) That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- (e) That the proposed non-standard gas proration unit does not exceed 5280 feet in length or width and consists of contiguous quarter-quarter sections.
- (f) That by copy of this letter of application by registered mail all offset operators are notified.

Therefore, Amerada Petroleum Corporation requests that the Oil Conservation Commission grant approval of this non-standard gas proration unit as proposed in this application.


