

In the matter of the application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the creation, abolishment, and extension of existing pools in Lea and Eddy Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations, abolishments, and extensions should not be made.

(a) Create a new pool in Lea County, New Mexico, classified as an oil pool for Pennsylvanian production, designated as the North Bagley Pennsylvanian Pool, and described as:

Twp. 11 South, Range 33 East
NW/4 of Section 10

and such other, etc.

(b) Create a new pool in Lea County, New Mexico, classified as a gas pool for Queen production, designated as the Vacuum-Queen Gas Pool, and described as:

Twp. 17 South, Range 34 East
SE/4 of Section 10

and such other, etc.

(c) Create a new pool in Lea County, New Mexico, classified as an oil pool for San Andres production, designated as the Dump-San Andres Pool, and described as:

Twp. 19 South, Range 39 East
NW/4 of Section 5

and such other, etc.

(d) Create a new pool in Lea County, New Mexico, classified as an oil pool for Devonian production, designated as the East Echols Devonian Pool, and described as:

Twp. 11 South, Range 38 East
NE/4 of Section 16

and such other, etc.

(e) Abolish the North Warren McKee Pool in Lea County, New Mexico and described as follows:

Twp. 20 South, Range 38 East

SW/4 of Section 8
NW/4 of Section 7
S/2 of Section 7
W/2 of Section 17
All of Section 18
N/2 NE/4 of Section 19
N/2 NW/4 of Section 20

and such other, etc.

(f) Extend the Bagley Upper Pennsylvanian Gas Pool Boundary in Lea County, New Mexico, to include therein:

Twp. 12 South, Range 33 East

NE/4 of Section 4

and such other, etc.

(g) Extend the Eumont Gas Pool Boundary in Lea County, New Mexico, to include therein:

Twp. 20 South, Range 37 East

S/2 NW/4 of Section 12

and such other, etc.

(h) Extend the Hackberry Yates Pool Boundary in Eddy County, New Mexico, to include therein:

Twp. 19 South, Range 30 East

S/2 NE/4 of Section 36

and such other, etc.

(i) Extend the Millman Pool Boundary in Eddy County New Mexico, to include therein:

Twp. 19 South, Range 28 East

NW/4 NW/4 of Section 17

and such other, etc.

(j) Extend the Red Lake Pool Boundary in Eddy County, New Mexico, to include therein:

Twp 18 South, Range 27 East
NW/4 of Section 7

and such other, etc.

(k) Extend the Vacuum Pool Boundary in Lea County, New Mexico, to include therein:

Twp. 17 South, Range 34 East
N/2 of Section 2

and such other, etc.

(l) Extend the Warren-McKee Pool Boundary in Lea County, New Mexico, to include therein:

Twp. 20 South, Range 38 East
SW/4 of Section 8
NW/4 of Section 7
S/2 of Section 7
All of Section 18
W/2 of Section 17
N/2 NE/4 of Section 19
N/2 NW/4 of Section 20

and such other, etc.
