ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 14, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 14<sup>th</sup> day of June, 1958, the Commission, a quorum being present, having considered the application and the evidence adduced and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Pubco Petroleum Corporation, seeks the establishment of temporary 80-acre spacing and the promulgation of Special Rules and Regulations for the Verde-Gallup Oil Pool in San Juan County, New Mexico.
- (3) That the applicant has failed to prove that the Verde-Gallup Oil Pool can be efficiently drained and developed on an 80-acre spacing pattern.
- (4) That the drilling and spacing of wells in the Verde-Gallup Oil Pool should continue to be governed by Rule 104 of the Commission Rules and Regulations.

IT IS THEREFORE ORDERED:

- (1) That the application of Pubco Petroleum Corporation for the establishment of temporary 80-acre spacing and for the promulgation of Special Rules and Regulations for the Verde-Gallup Oil Pool in San Juan County, New Mexico, be and the same is hereby denied.

(2) That the drilling and spacing of wells in the Verde-Gallup Oil Pool shall continue to be governed by Rule 104 of the Rules and Regulations of the Oil Conservation Commission of New Mexico.


