ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on September 17, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 29th day of September, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, the Gallegos-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, to the Otero-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool, the East Campanero-Dakota Pool, and the Otero-Gallup Oil Pool, all in Rio Arriba County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco-Maseverde Pool, both in San Juan and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


