THE APPLICATION OF THE OIL CONSERVATION  
COMMISSION UPON ITS OWN MOTION FOR AN  
ORDER EXTENDING AND CREATING CERTAIN  
POOLS IN LEA, EDDY, AND ROOSEVELT  
COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 17, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 24<sup>th</sup> day of December, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Abo formation, said pool to bear the designation Dayton Abo Pool. Said Dayton-Abo Pool was discovered by E. P. Campbell, Cockerham Well No. 1, located in the NE/4 Section 34, Township 18 South, Range 26 East, NMPM. It was completed September 20, 1958. The proportional factor for allowable purposes for said Dayton-Abo Pool shall be 1.33 as provided by Order R-1281, dated November 5, 1958.
- (3) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation Little Lucky-Lake-Devonian Pool. Said Little Lucky-Lake Devonian Pool was discovered by The Texas Company, Peery Federal, Well No. 1, located in the NE/4 Section 29, Township 15 South, Range 30 East, NMPM. It was completed October 12, 1958. The top of the perforations is at 11,050 feet.
- (4) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from

the Pennsylvanian formation, said pool to bear the designation East Milnesand-Pennsylvanian Pool. Said East Milnesand-Pennsylvanian Pool was discovered by The Texas Company, R. O. Champeau Federal Well No. 1, located in the NW/4 Section 12, Township 8 South, Range 35 East, NMPM. It was completed September 23, 1958. The top of the perforations is at 9237 feet.

(5) That there is need for certain extensions to the Empire-Abo Pool, and to the West Henshaw-Grayburg Pool, both in Eddy County, New Mexico, and to the Justis-Blinsbry Pool, the Justis-Drinkard Pool, the Justis-Fusselman Pool, the King-Wolfcamp Pool, the Langlie-Mattix Pool, the Teas Pool, the Penrose-Skelly Pool, the South Vacuum-Devonian Pool, the Warren-Blinsbry Gas Pool, and the Warren-Tubb Gas Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as an oil pool for Abo production, be and the same is hereby created and designated as the Dayton-Abo Pool, consisting of the following-described area:

TOWNSHIP 18 SOUTH, RANGE 26 EAST, NMPM  
Section 34: NE/4

(b) That a new pool in Chaves County, New Mexico, classified as an oil pool for Devonian production, be and the same is hereby created and designated as the Little Lucky Lake-Devonian Pool, consisting of the following-described area:

TOWNSHIP 15 SOUTH, RANGE 30 EAST, NMPM  
Section 29: NE/4

(c) That a new pool in Roosevelt County, New Mexico, classified as an oil pool for Pennsylvanian production, be and the same is hereby created and designated as the East Milnesand-Pennsylvanian Pool, consisting of the following-described area:

TOWNSHIP 8 SOUTH, RANGE 35 EAST, NMPM  
Section 12: NW/4

(d) That the Empire-Abo Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 18 SOUTH, RANGE 27 EAST, NMPM  
Section 2: S/2  
Section 3: SE/4

(e) That the West Henshaw-Grayburg Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 16 SOUTH, RANGE 30 EAST, NMPM  
Section 3: SE/4

(f) That the Justis-Blinebry Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM  
Section 13: SW/4

(g) That the Justis-Drinkard Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM  
Section 13: SW/4  
Section 24: SE/4  
Section 25: NW/4

(h) That the Justis-Fusselman Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 25: NW/4

(i) That the King-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 13 SOUTH, RANGE 37 EAST, NMPM  
Section 24: SE/4

(j) That the Langlie-Mattix Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 22 SOUTH, RANGE 37 EAST, NMPM  
Section 31: SE/4

(k) That the Penrose-Skelly Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 31: W/2 NW/4

(l) That the Teas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


