MR. PORTER: Proceed next to Case 1570.

MR. PAYNE: Case 1570. Southeastern New Mexico nomenclature case calling for an order for the creation of new pools and extension of existing pools in Lea, Eddy, Chaves, and Roosevelt Counties, New Mexico.

(Witness sworn)

JOHN W. RUNYAN,

called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

BY: MR. PAYNE:

- Q Will the witness please state his name and position?
- A John W. Runyan, geologist for the Oil Conservation Commission.
 - Q Mr. Runyan, in your official capacity as geologist

for the Oil Conservation Commission, have you had an opportunity to make a study concerning necessity or desirability for creation of new pools and extension of existing pools in Lea, Eddy, Chaves, and Roosevelt Counties, New Mexico?

- A Yes, sir, I have.
- Q What are your recommendations concerning extension of a new oil pool for Abo production?

A I recommend that a new pool be created and called the Dayton-Abo Pool, and this is due to the discovery well-E.P.Campbell-Cockerham #1 A in Unit A of Section 34, Township 18 South, Range 26 East, completed in the Abo 9/20/58, and the depth of the casing shoe was 4,205 feet. It is open hole completion.

- Q What do you recommend as the vertical limits?
- A I recommend the vertical limits be the Abo formation.
- Q What are your recommendations as the horizontal limits?
- A The horizontal limits I recommend as the SE/4 of Section 34 -- no, the NE/4 of Section 34, sorry.
- Q What are your recommendations concerning creation of a new oil pool for the Devonian formation?

A I recommend a new oil pool be created called the Little Lucky Lake-Devonian Pool, and this is due to the discovery well of The Texas Company-Peery Federal #1 located in Unit G of Section 29, Township 15 South, Range 30 East, completed the 10th, 12/1958, and the top of perforation 11,050 feet.

Q What do you recommend as the vertical limits?

A I recommend that the vertical limits be Devonian formation, and the horizontal limits of the Pool the NE/4 of Section 29.

Q What are your recommendations concerning creation of a new oil pool for Pennsylvanian production?

A I recommend that a new oil pool be created and called the East Milnesand-Pennsylvanian Pool. This is due to the discovery of The Texas Company, the R. P. Champeau Federal #1 in Unit E of Section 12, Township 8 South, Range 35 East, completed in the Pennsylvanian 9/23/1958. Top of perforation, 9,237 feet.

Q What do you recommend as the vertical limits?

A I recommend the vertical limits be the Pennsylvanian formation, and the horizontal limits, NW/4 of Section 12.

Q What are your recommendations concerning extension of Empire-Abo Pool?

A I recommend that the Empire-Abo Pool be extended as shown on Exhibit 1, and also an unadvertised portion being the SE/4 of Section 2, Township 18 South, Range 27 East.

Q For what reason do you recommend this extension?

A I recommend this extension due to five wells capable of producing from this pool.

Q What are your recommendations concerning extension of the West Henshaw-Grayburg Pool?

A I recommend this Pool be extended as shown on Exhibit 1, due to one well capable of producing from this Pool.

- Q What are your recommendations concerning extension of Justis-Blinebry Pool?
- A I recommend that this Pool be extended as shown on Exhibit I due to one well capable of producing from this Pool.
- Q What are your recommendations concerning extension of Justis-Drinkard Pool?
- A I recommend that this Pool be extended as shown on Exhibit 1, and also an unadvertised portion being the SE/4 of Section 24, Township 25 South, Range 37 East, and this is due to four wells capable of producing from this Pool.
- Q What are your recommendations concerning extension of Justis-Fusselman Pool?
- A I recommend this Pool be extended as shown on Exhibit l due to two wells capable of producing from this Pool.
- Q What are your recommendations concerning extension of the King-Wolfcamp Pool?
- A I recommend that this Pool be extended as shown on Exhibit I due to one well capable of producing from this Pool.
- Q What are your recommendations concerning extension of Langlie-Mattix Pool?
- A I recommend that this Pool be extended as shown on Exhibit 1 due to one well capable of producing from this Pool.
- Q What are your recommendations concerning extension of the Penrose-Skelly Pool?
 - A I recommend this Pool be extended as shown on Exhibit 1

due to one well capable of producing from this pool.

Q What are your recommendations concerning extension of the Teas Pool?

A I recommend that this Pool be extended as shown on Exhibit 1 due to one well capable of producing from this Pool.

Q What are your recommendations concerning extension of the South Vacuum-Devonian Pool?

A I recommend that this Pool be extended as shown on Exhibit 1, and also an unadvertised portion, being the NE/4 of Section 27, Township 18 South, Range 35 East. This is due to two wells capable of producing from this Pool.

Q What are your recommendations concerning extension of Warren-Blinebry Gas Pool?

A I recommend that this Pool be extended as shown on Exhibit 1 due to one well capable of producing from this Pool.

Q What are your recommendations concerning extension of Warren-Tubb Gas Pool?

A I recommend this Pool be extended as shown on Exhibit 1 due to one well capable of producing from this Pool.

Q Mr. Runyan, have you prepared exhibits substantiating your recommendations?

- A Yes, sir.
- Q How are they designated?
- A Designated Exhibit No. 1 and Exhibits No. 1-A through 1-0.

MR. PAYNE: Mr. Commissioner, at this time I move for the introduction of Exhibits 1-A through 1-0 in Case 1570.

MR. PORTER: Without objection, the Exhibits will be admitted. Anyone have a question of Mr. Runyan? The witness may be excused.
