ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 13, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 13<sup>th</sup> day of August, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool, the Otero-Chacra Pool, the Escrito-Gallup Oil Pool, and the Otero-Gallup Oil Pool, all in Rio Arriba County, New Mexico, to the West Kutz-Fruitland Pool, the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Gallegos-Gallup Oil Pool, and the Horseshoe-Gallup Oil Pool, all in San Juan County, New Mexico, to the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the West Kutz-Fruitland Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


