ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on September 30, 1959, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 19th day of October, 1959, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Continental Oil Company, is the co-owner operator of the E/2 SE/4 of Section 15 and the W/2 SW/4 of Section 14, both in Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.
- (3) That the applicant proposes to drill the SEMU Well No. 70 at a location 1980 feet from the South line and 660 feet from the East line of said Section 15.
- (4) That the applicant proposes the establishment of a 160-acre non-standard gas unit in the Weir-Tubb Gas Pool consisting of the E/2 SE/4 of Section 15 and the W/2 SW/4 of Section 14, to be dedicated to the said SEMU Well No. 70.

(5) That it would be impractical to communitize the adjoining acreage to form a standard gas unit.

(6) That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

That a 160-acre non-standard gas unit in the Weir-Fubb Gas Pool, consisting of the E/2 SE/4 of Section 15 and the W/2 SW/4 of Section 14, both in Township 20 South, Range 37 East, N40P1, Lea County, New Mexico, be and the same is hereby established. Said unit is to be dedicated to the applicant's SEMU Well No. 70, to be located 1980 feet from the South line and 660 feet from the East line of said Section 15.
