Dear Mr. Porter:

In accordance with Rule 5 (a), Order 520, Argo Oil Corporation hereby requests that a public hearing be called covering the assignment of 80 acres, being the W/2 of NW/4 of Section 22, T-25-S, R-37-E to their B. T. Lanehart Well No. 1. There is now 80 acres assigned to this well being the E/2 of NE/4 of Section 21, T-25-S, R-37-E, Jalmat Field, Lea County, New Mexico. This well is located 2310' from the North Line and 990' from the East Line of Section 21 and was completed on December 26, 1936.

The W/2 of the NW/4 of Section 22 has been tied up in legal proceedings which caused the delay in assigning this acreage to the B. T. Lanehart Well No. 1 Unit.

We are enclosing, in duplicate, Gas Well Plat showing the proposed unit and an Area Map showing the offset operators.

We are, by copy of this letter, advising all operators in Section 21 and Section 22 and all offset operators within 1500' of the well.
