GENTLEMEN:

PLEASE ACCEPT THIS LETTER AS THE APPLICATION OF BOLLER & NICHOLS AND LEONARD NICHOLS FOR AN ORDER AUTHORIZING A WATER-FLOOD PROJECT IN THE ROBERTS GRAYBURG POOL, LEA COUNTY, NEW MEXICO. PLEASE SCHEDULE THIS MATTER FOR HEARING BEFORE AN EXAMINER AT THE EARLIEST CONVENIENT DATE.

WE PROPOSE TO INSTITUTE A WATER-FLOOD PROJECT IN THE ROBERTS POOL, WITH A PROJECT AREA CONSISTING OF OUR ILES, ILES X, PHILLIPS STATE LEXCO, A. C. TAYLOR A, A. C. TAYLOR F, A. C. TAYLOR G, W. B. TRIMBLE A, W. B. TRIMBLE B, COMPRISING S/2 SECTION 3, N3/4 SECTION 10 (EXCEPT THE SW NW & NW/SW), SW/4 & S/2 SE/4 SECTION 2 AND SECTION 11 (EXCEPT THE E/2 NE/4 & S/2 SW/4), ALL BEING IN TOWNSHIP 17 SOUTH, RANGE 32 EAST, NMPM, LEA COUNTY, NEW MEXICO.

WE PROPOSE TO INJECT WATER INTO THE GRAYBURG FORMATION THROUGH THE FOLLOWING DESCRIBED WELLS, AS SHOWN ON THE ATTACHED PLAT:
