ORDER CREATING AND EXTENDING CERTAIN  
POOLS IN RIO ARriba AND SAN JUAN COUNTIES,  
NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 13, 1960, at Hobbs, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 19th day of April, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new pool in Rio Arriba County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Puerto Chiquito-Gallup Oil Pool. Said Puerto Chiquito-Gallup Oil Pool was discovered by Intex Oil Company USL Alto Well No. 1, located in the NW/4 NE/4, Section 5, Township 26 North, Range 1 East, NMPM. It was completed January 17, 1960. The top of the perforations is at 1785 feet.
- (3) That there is need for certain extensions to the Pine Lake-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool and the South Blanco-Dakota Pool, all in Rio Arriba County, New Mexico; to the West Kutz-Pictured Cliffs Pool, the Angels Peak-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool and the West Kutz-Dakota Pool, all in San Juan County, New Mexico; and to the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

- (a) That a new pool in Rio Arriba County, New Mexico,

classified as an oil pool for Gallup production, be and the same is hereby created and designated as the Puerto-Chiquito-Gallup Oil Pool, consisting of the following described area:

(b) That the Pine Lake-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined and described, be and the same is hereby extended to include therein:




