ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on September 14, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 16th day of September, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Pine Lake-Pictured Cliffs Pool, the South Blanco-Pictured Cliffs Pool, the Tapacito-Pictured Cliffs Pool, and the Escrito Gallup Oil Pool, all in Rio Arriba County, New Mexico, to the Artec-Pictured Cliffs Pool, to the Horseshoe-Gallup Oil Pool, to the Verde Gallup Oil Pool, to the Angels Peak-Dakota Pool, to the West Blanco-Dakota Pool, and to the West Ruts-Dakota Pool, all in San Juan County, New Mexico, and to the Ballard-Pictured Cliffs Pool in San Juan, Sandoval and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Artec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

That the effective date of this order and of all the extensions included herein shall be October 1, 1960.

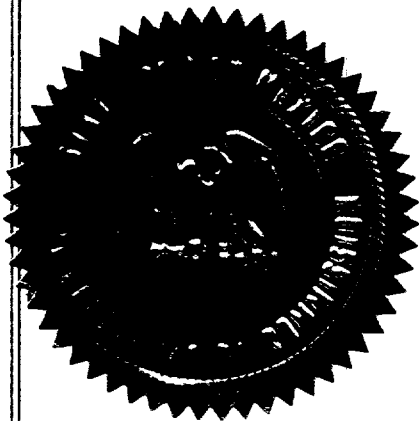
