It is our understanding that on November 30, 1960, in the subject docket and case, the Commission will consider the application of Robinson Bros Oil Producers for 320 acre spacing for production of natural gas from its Manry Elliott No. 1 well, located in Section 22, Township 11 South, Range 31 East, Chaves County, New Mexico.


Trice Production Company contemplates the drilling of a Pennsylvanian test well located South of the above described Manry Elliott No. 1 well, such well to be commenced by Trice within the near future.

As an offsetting operator, Trice Production Company agrees with Robinson Bros Oil Producers that proper spacing for Pennsylvanian natural gas production in this area should be 320 acres. From present production history, it is the opinion of Trice that an 11,000 foot well cannot be economically justified in this area on 160 acre spacing.
