Q Mr. Kendrick, in your position with the Commission, have you determined that certain pools in Rio Arriba, San Juan, and Sandoval Counties, New Mexico should be extended?

A I have.

Q Have you prepared an Exhibit substantiating that determination?

A Yes.

Q Is that identified as Exhibit No. 1?

A It is.

Q What is your recommendation concerning the extension of the Aztec-Pictured Cliffs Pool?

A That it be extended as shown in paragraph (a) of Exhibit 1.

Q What is your recommendation concerning the extension of the Ballard-Pictured Cliffs Pool?

A That the pool be extended as shown in paragraph (b) of Exhibit 1, on the basis of two wells completed therein.

Q What is your recommendation concerning the extension of the Tapacito-Pictured Cliffs Pool?

A That the Pool be extended as shown in paragraph (c) of Exhibit 1, on the basis of three wells completed therein.

Q What is your recommendation concerning the extension of the Blanco-Mesaverde Pool?

A That the Pool be extended as shown in paragraph (d)

A That the Pool be extended as shown in paragraph (f) of Exhibit 1, on the basis of five wells completed therein.

Q What is your recommendation concerning the extension of the Devils Fork-Gallup Pool?

A That the Pool be extended as shown in paragraph (g) of Exhibit 1, on the basis of one well completed therein.

Q What is your recommendation concerning the extension of the Escrito-Gallup Oil Pool?

A That the Pool be extended as shown in paragraph (h) of Exhibit 1, on the basis of two wells completed therein.

Q What is your recommendation concerning the extension of the Horseshoe-Gallup Oil Pool?
