Dear Mr. Porter:

I attach a plat showing this non-standard location, the acreage to be dedicated, and the offset ownership. I also enclose, for your information, my unfiled C-101 and C-128.

The necessity for this unorthodox location is based on topographical conditions because this is about the only vacant lot on my lease. You may notice that it falls at the corner of Houston and Snyder streets in a heavily populated section of Hobbs.

The location is unorthodox only because it is less than 300' from my lease boundary line. Shell's nearest well is more than 1100' west and Samedan's nearest well is 1100' south.

Today I am notifying the offset operators, Shell and Samedan, by registered mail, of my intent to drill this unorthodox location, and I am requesting their written consent. Carbon copies of these notifications and requests are enclosed for your information along with a photocopy of the Post Office Registration Receipt.

Thank you for considering my application. If Shell and/or Samedan return their written consent to me, I will forward them to you. If either of them protest to you, please schedule a hearing for me as soon as possible because my leases will expire November 15, 1961.

If anything more is required or desired from me for you to grant this exception, please let me know.
