ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 18, 1962, at Farmington, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 22nd day of October, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Blanco-Mesaverde Pool, the Boulder-Mancos Oil Pool, the Devils Fork-Gallup Pool and the Puerto Chiquito-Gallup Oil Pool in Rio Arriba County, New Mexico, the Aztec-Pictured Cliffs Pool and the Blanco-Pictured Cliffs Pool in San Juan County, New Mexico, and the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico.


