Gentlemen:

After studying the proposed forms recommended by Shell Oil Company to replace the present Form C-115, we note two major objections to this particular revision:

1. Our reports are manually computed and prepared by typewriter. For typewriter usage, the forms recommended by Shell would overcrowd the allotted information spaces. The necessary overcrowding of information would be difficult and time consuming, as well as being difficult to read.
2. These forms would also involve more breakdown under the section entitled "Disposition of Oil". At present, this information is provided on the lower part of the C-115 as a summary and lease total. Under the new proposal, the way we interpret it, is that each well would have to have a breakdown of runs, storage, trucking, etc.

Our main objection is that this form would probably be suitable for anyone with data processing equipment, but for typewriter use, it would present problems.

We would appreciate your giving extensive thought in considering this matter before making any proposed revision in the present C-115.
