This is to advise that Sun Oil Company is now in compliance with New Mexico Oil Conservation Commission Order No. R-2526, prohibiting the surface disposal of salt water into unlined pits in the Inbe-Pennsylvanian Pool, Lea County, ~~New Mexico~~. Sun has set a 250 barrel salt water accumulator tank on its only lease affected by this order, that being the State of New Mexico "A" lease. The water from the one well battery, which amounts to less than one barrel per day, will be accumulated in the tank and allowed to evaporate.
