Reference is made to the application of Kennedy Oil Company seeking to modify Order R-1110-C of the Oil Conservation Commission on which hearing was held June 10, 1964 as Case 3038. Although I am unable to find in the application that they are requesting permission to construct or convert wells to injection, the exhibits handed me by Mr. Losee, in the presence of Mr. John F. Russell, indicate that they do seek to activate two injection wells which are the Rowley No. 1-L in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 20 and Rowley No. 2 in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 20, both in T. 16 S., R. 31 E.

This office offers no objection to these wells being used as injection wells provided injection is through tubing under a packer with the packer set well below the known top of the cement surrounding the 5 $\frac{1}{2}$ " casing.
