APPLICATION

COMES T. J. SIVLEY, by his attorney, A. J. Losee,
and states:

1. Applicant is the operator of 3 wells producing in the Lynch-Yates Pool in Lea County, New Mexico. The wells are all situated upon Oil and Gas Lease Serial No. NM 039256 issued by the United States and covers, among other lands, the following lands in Lea County, New Mexico:

Township 20 South, Range 34 East, N.M.P.M.,

Section 28: S/2

2. The operator is presently disposing of approximately 1700 barrels of water per month produced in conjunction with the production of oil from said 3 wells, in one unlined pit located upon the NW/4 SE/4 of said Section 28.

3. There is attached hereto and by reference made a part hereof, a plat showing the location of the said 3 producing wells and the one unlined pit, together with the location of adjoining domestic and stock watering wells.

4. Applicant's 3 wells are all completed in compliance with Order No. R-111-A of the Oil Conservation Commission, (the "Commission"), and the volumes of water produced in conjunction with the production of oil from these 3 wells, have not constituted and it is not anticipated that it will constitute

any hazard to the fresh water supplies, if any, in the area.

5. The granting of an exception to Order No. R-3221 of the Commission to Applicant will prevent waste.

WHEREFORE, Applicant prays:

a) That an exception to Order No. R-3221 be granted to Applicant to permit the continuation, after January 1, 1969, of the disposal of water produced in conjunction with the production of oil from Applicant's 3 wells on the surface in Applicant's one unlined pit or on such other pits located upon the above described lands which are deemed necessary by Applicant.

b) In the alternative, that Applicant be granted an extension of time, for such reasonable period as the Commission may deem desirable, within which to comply with the provisions of paragraph No. 3 of said Order No. R-3221 of the Commission.

c) And for such other relief as may be just in the premises.
