Dear Mr. Medlock:

On February 28, 1974, Mr. W. A. Gressett, District Supervisor of Commission's District II, contacted you concerning your failure to file forms required by Oil Conservation Commission Rules and Regulations on the above captioned well. As of July 15, 1974, you had still not taken care of this matter.

Since you are apparently unwilling to comply with Commission rules and regulations, I have no choice but to cause a hearing to be set before an examiner of the Commission to determine whether or not an order should be issued requiring that this well be plugged and abandoned. You will receive notice of the hearing date.

Failure to comply with an order of the Commission can result in civil penalties of up to \$1000 per day pursuant to the provisions of Section 65-3-27, New Mexico Statutes Annotated, 1953 Compilation.



Application for Permit to Drill the subject well was approved on December 4, 1973, and to date, no additional reports have been received in this office.

According to the Scout report said well has been drilled to a TD of 840 and is currently testing. To bring our records up to date, please file Form C-103 reporting the spud date, setting and cementing of the surface and production casing. Said report to include size, grade, weight and amount of casing set; the type and amount of cement used (if cement circulated to surface so indicate) the WOC time and pressure test results, the perforations, treatment and results of same.

A small supply of said Form C-103 is enclosed, report to be submitted in triplicate.

FINDS:


That on the motion of the Commission the case should be
