

CASE 5513: Southeastern nomenclature case calling for the creation and extension of certain pools in Chaves, Lea, and Eddy Counties, New Mexico.

a) CREATE A new pool in Lea County, New Mexico, classified as a gas pool for Morrow production and designated as the North Bell Lake-Morrow Gas Pool. The discovery well is the Continental Oil Company Bell Lake Unit 4 Well No. 15 located in Unit K of Section 8, Township 23 South, Range 34 East, NMPM. Said pool would comprise:
