1 EXAMINER CATANACH: At this time we'll
2 call Case 10464, in the matter of the application
3 of the Oil Conservation Division on its own
4 motion for an order contracting and extending
5 certain pools in Rio Arriba, San Juan, and
6 Sandoval Counties, New Mexico.

7 I think we should also at this time
8 call Case 10474, in the matter of the application
9 of the Oil Conservation Division on its own
10 motion for an order creating and extending
11 certain pools in Chaves and Eddy Counties, New
12 Mexico.

13 Are there appearances in these cases?

14 MR. STOGNER: Mr. Examiner, I'm Michael
15 E. Stogner, petroleum engineer, Chief Hearing
16 Officer for the Oil Conservation Division here in
17 Santa Fe. I'm appearing today without counsel.
18 I'm ready to be sworn in.

19 **MICHAEL E. STOGNER**

20 Having been duly sworn upon his oath, was
21 examined and testified as follows.

22 EXAMINER CATANACH: You may proceed
23 with your testimony, Mr. Stogner.

24 MR. STOGNER: Mr. Examiner, Case No.
25 10464 is the nomenclature contracting and

1 extending certain pools in Rio Arriba, San Juan,
2 Sandoval Counties, New Mexico. That's District 3
3 in Aztec, New Mexico.

4 And I have in this case Exhibit No. 1,
5 which is data corresponding to the docket on
6 today's matter. And I might add, there were no
7 changes between the docket nor the exhibit
8 today. And I wish that be admitted into evidence
9 at this time.

10 EXAMINER CATANACH: Exhibit No. 1 in
11 Case 10464 will be admitted as evidence.

12 MR. STOGNER: In Case 10600 -- I'm
13 sorry. The other one.

14 EXAMINER CATANACH: 10474.

15 MR. STOGNER: Yes, sir. Thank you.
16 This is nomenclature for pools to be created and
17 extended in Chaves and Eddy Counties, New Mexico,
18 that being our District 2 out of Artesia, New
19 Mexico.

20 I have also for this case an exhibit
21 several pages long designated Exhibit No. 1. I
22 may point out, there are no differences between
23 the Exhibit No. 1 today nor the advertised case
24 on the docket for 10474. And I wish to admit
25 Exhibit No. 1 into evidence at this time.

1 EXAMINER CATANACH: Exhibit No. 1 in
2 Case 10474 will be admitted as evidence.

3 MR. STOGNER: I might add, Mr.
4 Examiner, I have appeared before the Division
5 before in the same capacity.

6 EXAMINER CATANACH: I see. Okay.
7 Anything further, Mr. Stogner?

8 MR. STOGNER: No.

9 EXAMINER CATANACH: There being nothing
10 further, Cases 10464 and 10474 will be taken
11 under advisement. And this hearing is
12 adjourned.
