TCCMY ROBERTS, being first duly sworn, states as follows:

1. That I am an attorney in the law firm of Tansey, Rosebrough, Gerding & Strother, P.C. in Farmington, New Mexico.

2. That I was retained to represent SG Interests I, Ltd., the applicant in Case No. 10567 filed with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests in the Basin-Fruitland Coal (Gas) Pool underlying the S/2 of Section 30, Township 29 North, Range 10 West, N.M.P.M., San Juan County, New Mexico.

3. That on September 21, 1992, in the course of my representation of SG Interests I, Ltd. in Case No. 10567, I mailed certified -- return receipt requested -- letters to Don Moris Davis and Tommy Key, uncommitted owners of leasehold operating rights interests in and under the subject lands, notifying them of the filing and docketing of the application in Case No. 10567.
