

1 EXAMINER STOGNER: Call the next case, No.
2 10648.

3 MR. STOVALL: Application of Seely Oil
4 Company for waterflood project, four unorthodox
5 injection well locations, and the Recovered Oil Tax
6 credit pursuant to New Mexico Enhanced Oil Recovery
7 Act, Lea County, New Mexico.

8 EXAMINER STOGNER: This case was heard
9 when, Mr. Carr?

10 MR. CARR: Mr. Examiner, this case was
11 heard on March 18, 1993. As you may recall, prior to
12 that hearing, we were in negotiations with BTA and Ray
13 Westall concerning the boundary of this waterflood
14 project and the corresponding unit. Agreements were
15 reached, but it was less than 20 days prior to the
16 March 18 hearing.

17 And on March the 5th, we provided notice of
18 various unorthodox well locations to the affected
19 offsetting operators, but at that time, at the time of
20 the hearing on March 18, the 20-day notice period had
21 not run. At that time you directed us to provide
22 additional notice.

23 We have done that. And what I have marked
24 as Exhibit A is my affidavit. Attached to the
25 affidavit are copies of letters providing the exact

1 well location for the unorthodox locations in the
2 unit. The return receipts are attached.

3 And other than offering Seely Exhibit A, we
4 would request that on the record made on March 18,
5 this case be taken under advisement.

6 EXAMINER STOGNER: Mr. Stovall, anything
7 further? In the readvertisement of this particular
8 instance, were you specific on the four locations?

9 MR. CARR: Yes.

10 EXAMINER STOGNER: Have you reviewed those
11 locations and they are correct? You're aware of --

12 MR. CARR: We checked them, and we believe
13 they are correct. And I also asked Seely to confirm
14 the locations were correct, and they reported that
15 they were.

16 EXAMINER STOGNER: Mr. Stovall?

17 MR. STOVALL: I have no questions.

18 EXAMINER STOGNER: Does anybody else have
19 any questions or anything to add? I shouldn't say
20 questions of Mr. Carr, since he is not a witness in
21 this matter. Anything further in Case No. 10648?

22 MR. CARR: No, Mr. Examiner, nothing
23 further.

24 EXAMINER STOGNER: This case will be taken
25 under advisement.
