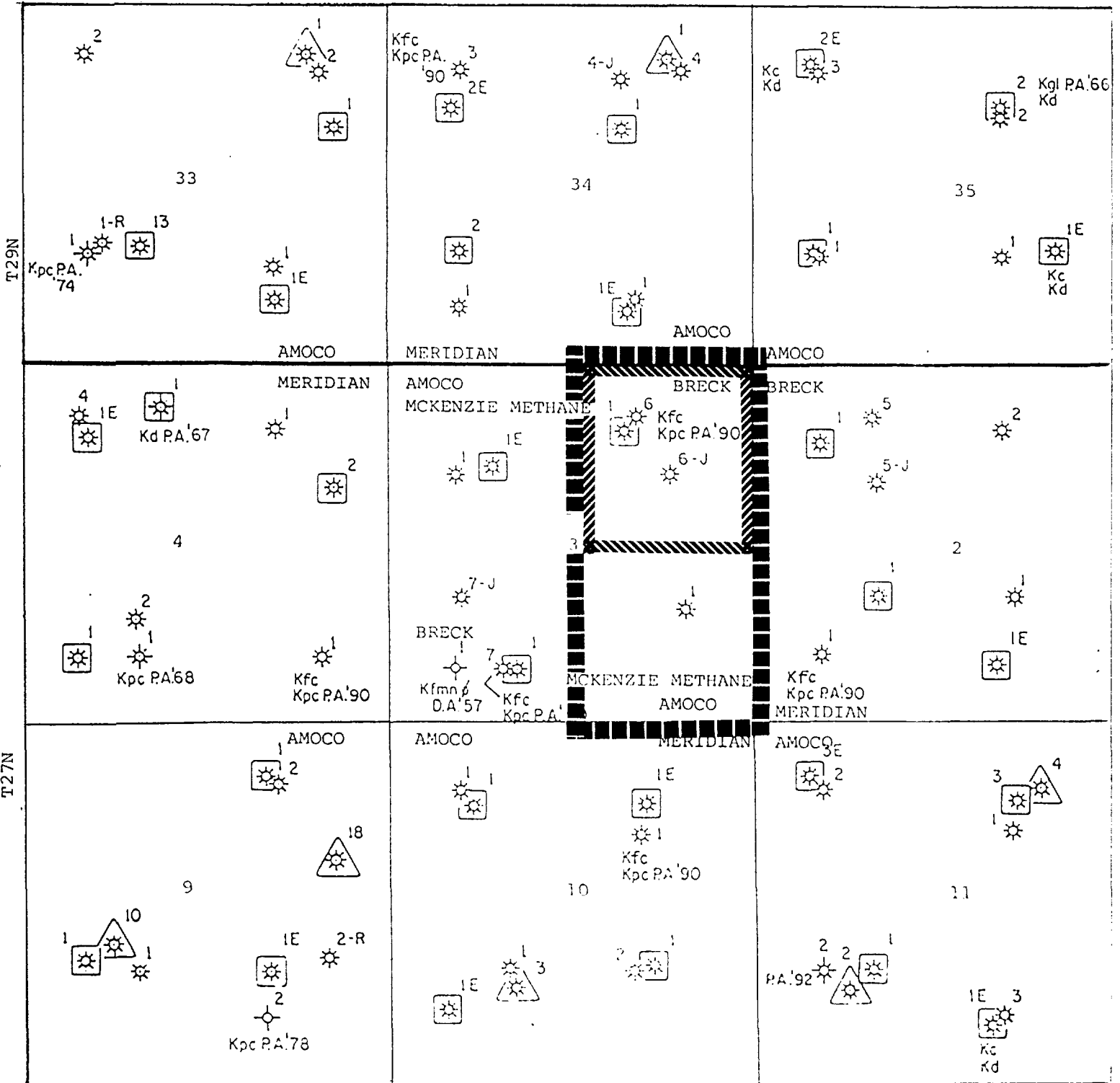

FACILITY SCHEMATIC

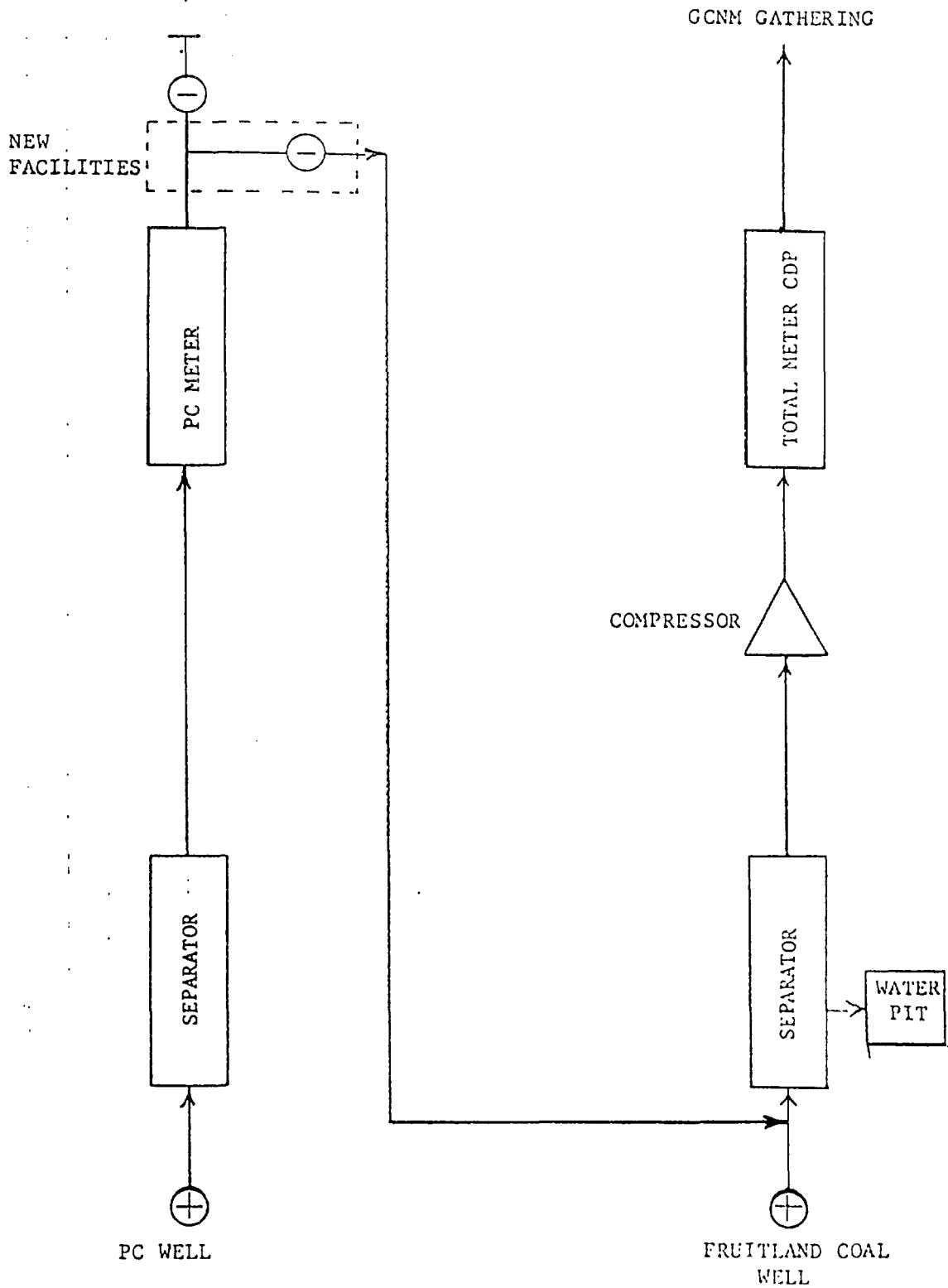
