16 Senior Petroleum Geologist.

17 Q Mr. Johnson, have you previously testi-  
18 fied before the Commission or its examiners and had your  
19 credentials accepted?

20 A Yes, I have.

21 Q Are you prepared to make recommendations  
22 to the Examiner today concerning the nomenclature of cer-  
23 tain pools in Lea and Roosevelt Counties, in Chaves and  
24 Eddy Counties, and in Rio Arriba, Sandoval and San Juan  
25 Counties?

1           A           I am.

2           Q           Are your recommendations prepared in the  
3 form of exhibits?

4           A           They are. Each one is labeled Exhibit  
5 One for each of the Cases Nos. 9548, 9549 and 9556.

6           Q           Are your exhibits accurate and have you  
7 reviewed them, Mr. Johnson?

8           A           Yes, I have.

9           Q           Thank you.

10                           MR. STOVALL: I move the

12 9548, 9549 and 9556.
