Dear Mr. Lemay:

Please reference the ~~Meridian Oil request~~ for administrative approval of an unorthodox gas well location on the subject well. This request was made in a Meridian Oil letter, addressed to you, dated November 8, 1988. As discussed, per the December 20, 1988, telecon between Mike Stogner, of your office, and Steve Reber, of this office, Tenneco Oil Company objects to the proposed spacing exception on the subject well. This proposed location is 165' from Tenneco's lease line and placement of the well in this location will obviously infringe on Tenneco's correlative rights.

As you are aware, Tenneco's Rocky Mountain Division was recently acquired by Amoco Production Company. Formal notification of this change is forthcoming, however, in the interim period, Tenneco is acting as Amoco's agent in this matter. Therefore, in the event Meridian Oil elects to take this matter before a hearing, notification should be made to Tenneco at the above address.
