6 Conservation Division as Chief Engineer.7 Q Mr. Lyon, have you previously testified  
8 before the Commission or its examiners and had your cre-  
9 dentials accepted?

11 Q Are you prepared to make recommendations  
12 to the Examiner today concerning the nomenclature of cer-  
13 tain pools in Chaves and Eddy Counties, New Mexico?

14 A Yes, I am.

15 Q Are your recommendations prepared in the  
16 form of an exhibit?17 A Yes, I think the advertisement serves as  
18 the exhibit, does it not?19 Q Plus I think you have -- what you have  
20 in the file is also your exhibit, I believe.21 A Oh, all right, let me find it. Yeah,  
22 okay.23 Q How is that exhibit denominated? Have  
24 you prepared that in the form of Exhibit A?

25 A Yes, I have.

1           Q           Would you please refer to Exhibit A and
