

In reference to Amerind's conditional waiver of objection for the unorthodox surface location of the J. R. Holt No. 2 well, the Hobbs Division agrees to the following:

- 1) Chevron will waive objection to any Amerind operated well with an unorthodox surface location in the S/2 of the NW/4 Section 2, T17S-R37E, provided such location is no closer than 420 feet from a lease line. As this tract is the only Amerind operated lease adjacent to and affected by the J. R. Holt #2 location, we feel that a simultaneous waiver on Chevron's part should be limited to that lease.
