We suggest the following to be used for the advertisement for this case:



APPLICATION

Comes now PACIFIC ENTERPRISES OIL COMPANY (USA), by and through its attorneys, Kellahin, Kellahin & Aubrey, and applies to the New Mexico Oil Conservation Division for approval of an unorthodox gas well location for a gas well to be drilled 660' FNL and 1400' FEL of Section 2, T10S, R26E, N.M.P.M., Chaves County, New Mexico, to be dedicated to a 320-acre spacing and proration unit consisting of the N/2 of said section, and in support thereof would show:

1. Applicant has the right to drill and develop the N/2 of Section 2, T10S, R26E, N.M.P.M., Chaves County, New Mexico, as shown on the plat attached hereto as Exhibit B.

2. Applicant proposes to drill its well through the Ordovician formation at an unorthodox gas well location 660' FNL and 1400' FEL of said Section 2 and to dedicate the N/2 of said section to the well.

3. The subject well requires an exception to the standard statewide rules for gas well locations in order to be at the optimum location to test the Ordovician formation in the N/2 of said section.

4. Applicant requests that this matter be set for hearing on the examiner's docket of November 1, 1989.

5. Notice to affected offset operators shown on Exhibit "A" is being sent as required by the rules of the Division.

WHEREFORE, applicant seeks approval of the application as requested.
