

Dear Mr. LeMay:

Yesterday, March 7, 1990, Siete Oil & Gas Corporation presented its evidence and testimony in support of the above-referenced application.

Today it has come to our attention that nomenclature Order R-9096, issued by the Division on January 11, 1990, expanded the Parkway Bone Springs Pool and abolished the South Parkway Bone Springs Pool, which had the effect of expanding Siete's notice requirements. Siete's application was filed shortly after issuance of Order R-9096. As a result, Siete will have to ask that the case be readvertised for an April 4, 1990 hearing date to afford any other operators or unleased mineral owners an opportunity for hearing following our notice requirements.

Based on the evidence which we submitted at the hearing yesterday, we feel strongly that there is little likelihood that there will be any protest of the application since all interest owners producing from the pool have already given Siete waivers of objection to the application. Chevron, U.S.A., which has the only other Bone Springs well in the area in the SW/4NE/4 of Section 2, Township 20 South, Range 29 East, Eddy County, has today agreed to sign a waiver. Chevron's well, the Eddy IK State No. 1, produces from a stray Bone Springs zone which is not one of the zones producing from Siete's wells.

Siete's presentation yesterday fairly demonstrated that the Parkway Bone Springs Pool is of limited extent and is fairly confined to Section 34, Township 19 South, Range 29



East. In retrospect, perhaps, Siete's application should have been to create a new pool in Section 34.

During the hearing we asked Mr. Catanach for an expeditious order since no one objected to the application and Mr. Catanach, we believe, was well satisfied that the GOR request was necessary to prevent waste in the pool. Obviously, that request will have to await compliance with the newly discovered notice requirements. We do, however, request interim administrative approval for Siete to produce its wells in Section 34, Township 19 South, Range 29 East, at a 10000 to 1 GOR limitation pending readvertisement of the case for April 4, 1990.



2. That the Pool is currently operated upon a GOR limitation in accordance with Rule 506 (a) of the Division's Rules and Regulations because no other GOR limitation has been established for the Pool.

WHEREFORE, this Applicant requests that this application be set for hearing at the next available hearing




Dear Mr. Padilla:

By letter dated January 9, 1990, you granted Siete Oil & Gas Corporation authorization for a special 30 day testing period for its Osage Federal Well No. 13.


