

2. The Applicant, Socorro Petroleum Company, is the current operator of Keel-West Waterflood Project approved by Division Order R-2268, R-2268-A, R-2268-B and WFX-585 and WFX-587.

3. The Keel-West Waterflood Project includes 16 wells located as shown on Exhibits "A" and "B" all in Township 17 South, Range 31 East, Loco Hills Pool.

4. In Addition, Applicant seeks approval of the H.B. West "B" Well No. 24, Unit A, Section 10, for injection.

5. Decline curve analysis indicates that 1,480,000 barrels of oil may be recovered as a result of increasing the injection pressure for the injection wells in the Keel-West Waterflood.

6. Log analysis of injection wells indicate that all injected water is being contained within the Grayburg San Andres formation.

7. A study of the area has shown that under the current limitation of .2 psi/ft. maximum surface injection pressure, water cannot be injected in volumes required to meet the economic limits for conducting an efficient waterflood project.

8. Injection conducted at 450 psi above the parting pressure of the formation will create a fracture that will not propagate outside of the vertical limits of the Grayburg San Andres formation.

9. The improved injectivity from increased pressure limitation for the waterflood operations in the Keel-West Unit will result in an estimated additional 1,480,000 barrels of oil being recovered from the area.

10. That a new pressure limitation of 450 psi above the formation parting pressure as determined by step-rate tests is requested for the Keel-West Unit wells as tabulated on Exhibit "A" attached hereto.

11. That attached hereto as Exhibit "C" is a list of names and addresses of all interested parties to whom Applicant has sent notice of the hearing of the Application set for May 2, 1990 in accordance with the requirements of Rule 1207(4).

12. That approval of the Application will prevent waste, protect correlative rights, and will not constitute a risk to fresh water sources.

WHEREFORE, Applicant requests that this matter be set for hearing and that after notice and hearing the Application be granted as requested.





2. The Applicant, Socorro Petroleum Company, is the current operator of Keel-West Waterflood Project approved by Division Order R-2268, R-2268-A, R-2268-B and WFX-585 and WFX-587.

3. The Keel-West Waterflood Project includes 16 wells located as shown on Exhibits "A" and "B" all in Township 17 South, Range 31 East, Loco Hills Pool.

4. In Addition, Applicant seeks approval of the H.B. West "B" Well No. 24, Unit A, Section 10, for injection.

5. Decline curve analysis indicates that 1,480,000 barrels of oil may be recovered as a result of increasing the injection pressure for the injection wells in the Keel-West Waterflood.

6. Log analysis of injection wells indicate that all injected water is being contained within the Grayburg San Andres formation.

7. A study of the area has shown that under the current limitation of .2 psi/ft. maximum surface injection pressure, water cannot be injected in volumes required to meet the economic limits for conducting an efficient waterflood project.

8. Injection conducted at 450 psi above the parting pressure of the formation will create a fracture that will not propagate outside of the vertical limits of the Grayburg San Andres formation.

9. The improved injectivity from increased pressure limitation for the waterflood operations in the Keel-West Unit will result in an estimated additional 1,480,000 barrels of oil being recovered from the area.
