

Com 34 No. 1 Well to be drilled at a standard coal gas well location 790 FNL and 1216 FEL (Unit A) of said Section 34. The Estate of Thelma Ford Simmons dba D. J. Simmons Company requests that such order designate The Estate of Thelma Ford Simmons dba D. J. Simmons Company as the Operator of the proposed well and that it provide for the recovery by The Estate of Thelma Ford Simmons dba D. J.
