Gentlemen:

Enron Oil & Gas Company hereby proposes the drilling of the referenced well as an approximate 8,700' Bone Springs Test. The proration unit for this well will be the NE/4 NW/4. In this regard enclosed please find two (2) copies of Enron's AFE detailing the estimated costs.

According to Enron's records, the working interest ownership in this well will be as follows:

As your files will reveal, this is the second well to be drilled pursuant to the agreements between our respective companies. These agreements cover the West Half (W/2) of said Section 18 and were put in effect when the Canadian Kenwood "18" #1 Well (Initial Well) was drilled as a Morrow producer.

The Operating Agreement ("O/A") dated August 15, 1980 (copy enclosed) covers the lands in this W/2 and in particular this well proposal. This O/A was executed by the original drilling participants in the #1 well, being Holly Energy, Inc. (now Enron Oil & Gas Company), Lawbar Petroleum, Inc. and Hondo Drilling Company.

The remaining parties, being Canadian Kenwood Company, Southland Royalty Company (now Meridian Oil, Inc.), and the T. R. Parker Estate all executed separate Farmout Agreements into Holly Energy, Inc. These Farmouts stated that an Operating Agreement would become effective at payout of the above mentioned #1 well. Inasmuch as the #1 well has not paid out, we have enclosed a Ratification Agreement to the above mentioned O/A dated August 15, 1980 in order to cover this subsequent well proposal.



Gentlemen:

This letter is being written on behalf of my client,
Hondo Drilling Company, with reference to the above proposed
operations and an Amendment to the Operating Agreement
between the parties executed by Hondo Drilling Company on
May 31, 1990. The original Operating Agreement had no
provision with regard to the interests of parties in
subsequent wells, while the Amendment executed May 31, 1990,
by Hondo Drilling Company reduces Hondo's interest in
subsequent wells by one-half. It is Hondo's position that
these figures are inaccurate, and by this letter Hondo is
giving you notice that it is retracting its Ratification and
Amendment of the Operating Agreement on the basis of mistake
and failure of consideration.

The Farmout Agreements from Canadian Kenwood and the
Estate of T. R. Parker on these lands, as well as the
Assignments from these parties, are identical. The
definition of payout in these agreements in effect states
that payout will not occur until the cost of drilling,
equipping and operating the initial well on the acreage
earned has paid out. The acreage earned under the Farmout
Agreement and Assignment is the entire W/2 of the Section,
subject to depth limitations. There is no provision
regarding subsequent wells. Also, the Southland Royalty
Assignment and Farmout Agreement, copies of which are
enclosed herewith, do not contain any definition of payout.
It is Hondo's belief that payout has not occurred on this
property and will not occur until the payout of the initial
well, which is a producing well.





Pursuant to our conversation, enclosed please find a copy of the following:

1. Farmout Option Agreement dated October 24, 1979 between Canadian Kenwood Company and Holly Energy, Inc. (Enron's predecessor).
2. Assignment of Operating Rights from Canadian Kenwood Company to Holly Energy, Inc., Hondo Drilling Company, and Lawbar Petroleum, Inc. pursuant to the Farmout in 1. above.
3. Farmout Agreement dated June 20, 1980 between the Co-personal Representatives of the T. R. Parker Estate and Holly Energy, Inc.
4. Assignment of Operating Rights from the T. R. Parker Estate to Holly Energy, Inc., Hondo Drilling Company, and Lawbar Petroleum, Inc. pursuant to the farmout in 3. above.
5. Copy of Operating Agreement dated August 15, 1990 between Holly Energy, Inc., Hondo Drilling Company, and Lawbar Petroleum, Inc.
6. Copy of Communitization Agreement No. RNM-058 communitizing the W/2 Section 18, T18S, R31E, N.M.P.M., as to the Morrow Formation. Our files did not reflect a termination of this Agreement by the BLM, however as you aware, the Canadian Kenwood 18 Fed Com #1 was plugged back to the Bone Springs formation in March of 1988. Therefore since this was the only Morrow producer on the Communitized area, the agreement has terminated under its own terms.

Gentlemen:

In response to Allen & Isbell's letter on behalf of Hondo Drilling Company dated July 2, 1990, Enron Oil & Gas Company's legal staff has conducted a thorough review of the contracts affecting the referenced well with specific attention given to subsequent wells and the payout provisions of the Farmout Agreements from Canadian Kenwood Company, the Estate of T. R. Parker, and Southland Royalty. It is Enron's conclusion that since payout has not occurred with respect to the initial well (Canadian Kenwood 18 Fed Com #1), then until such payout, any subsequent wells, including the referenced well, shall be drilled on a before payout basis.

Enron apologizes for confusion caused with its letter of May 22, 1990 proposing the referenced well, being the first subsequent well under the above noted agreements. As you are aware, most current industry agreements provide that subsequent wells are drilled on an after payout basis in this situation. Since the original Operating Agreement did not address the interests of the parties in subsequent wells, Enron felt it equitable to follow such industry standards. However, as Allen & Isbell's letter reflects, the Farmout Agreements ultimately dictate the treatment of the interests. These Farmouts all require payout of the initial well before the after payout parties own a working interest. Therefore in honoring its contracts, Enron plans to proceed based on the before payout working interests, being Enron Oil & Gas Company 50%, Hondo Drilling Company 25% and Lawbar Petroleum, Inc. 25%.

A compulsory pooling application has been filed with the New Mexico Oil Conservation Division, a copy of which has been provided your companies. This matter is set for hearing on the August 8, 1990 docket. Should the after payout parties not agree with the conclusion above, and claim to own a current working interest, Enron feels it must follow through with the pooling action to provide a commitment of any working interest, whether existing or claimed. As none of the parties have advised Enron of their position in response to Allen & Isbell's letter, it is requested that you immediately do so in writing. If all parties are in agreement that the before payout interests are required in drilling the referenced well, the pooling action will not be necessary.

In this regard, and with regard to Lawbar Petroleum, Inc. and Hondo Drilling Company, Enron again proposes the drilling of the referenced well as an approximate 8,700' Bones Spring's Test at the referenced location with the NE/4 NW/4 to be the dedicated proration unit. Two (2) copies of Enron's AFE detailing the estimated costs are enclosed. It is requested that you make your election in writing to participate or go non-consent under this well proposal as to your separate 25% working interest's. Should you elect to participate, please execute and return one (1) AFE with your election letter. As this matter has been pending sometime, it is hoped that your election will be accelerated in advance of the required thirty days.
