




Re: Application of Union Oil Company of California d/b/a Unocal for Pool
Contraction and Special Pool Rules, Eddy County, New Mexico

Gentlemen:

This letter is to advise you that Union Oil Company of California d/b/a Unocal has filed an application with the New Mexico Oil Conservation Division seeking contraction of the Esperanza-Delaware Pool, to exclude therefrom Sections 28 and 33 of Township 21 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. Unocal also seeks the promulgation of Special Pool Rules for the Esperanza-Delaware Pool including provisions providing for a special oil allowable of 120 barrels of oil per day.

This application has been set for hearing before a Division Examiner on August 22, 1990. You are not required to attend this hearing, but as an operator of a well or owner of an unleased mineral interest within the pool, or as an operator of a well within one (1) mile of the current pool boundaries of the Esperanza-Delaware Pool, you may appear and present testimony. Failure to appear in this hearing and become a party of record will preclude you from challenging this matter at a later date. Anyone interested in presenting testimony in this case should file a Pre-Hearing Statement with the Division by 4:00 o'clock p.m. on Friday, August 17, 1990.
