Re: Increasing New Mexico Oil Production

Dear Mr. LeMay:

On September 24, 1990 you held an open meeting in Santa Fe to discuss potential methods for increasing oil production in the State of New Mexico during the current energy crunch. I believe this meeting was very informative and that some ideas were put forth that might help your Division accomplish such an increase. Toward the end of this meeting you requested that companies furnish information which could give the Commission an idea of how much oil could be produced if changes in allowable were made.

During this meeting the Dagger Draw Field, located southwest of Artesia, Eddy County, New Mexico, was discussed by representatives of Conoco and myself. Yates Petroleum feels that additional oil can be produced from the Dagger Draw Field, as apparently Conoco does, by increasing the allowable for that field.

Yates Petroleum Corporation has made application to NMOCD for a hearing requesting that the Pool Rules in the North Dagger Draw Field and South Dagger Draw Field be made equivalent as to allowables and GOR even though the spacing for the two fields are different. We will assume for the purpose of the information provided in this letter that our application will be approved.

3 on doubling.

In the Dagger Draw Field, including both North Dagger Draw and South Dagger Draw, Yates Petroleum Corporation-operated wells produce an approximate total of 4500 barrels of oil per day at the present time. With a doubling of the allowable, we project that Yates Petroleum Corporation-operated wells could possibly produce a total of 5100 barrels of oil per day with no additional drilling or expenditure. With the drilling of fifteen or so additional wells in the area, we believe that production could be increased, with a greater allowable, to an approximate 6500-7000 barrels of oil per day. This increase, however, would depend upon the drilling of additional wells and installation of additional facilities which, as I stated in Monday's meeting, would require more than a temporary ninety-day change in allowable to justify such expenditure.
