We suggest the following to be used for the advertisement for this case:



COMES NOW MERIDIAN OIL, INC., by and through its attorneys, KELLAHIN, KELLAHIN & AUBREY, and applies to the New Mexico Oil Conservation Division for approval to drill its Frost No. 500 well at an unorthodox coal gas well location 1040 feet FNL and 130 feet FEL of Section 26, T27N, R10W, N.M.P.M., San Juan County, New Mexico and to dedicate the E/2 of said Section 26 to the subject well and in support thereof states:

1. Applicant is a working interest owner and the operator of the E/2 of Section 26, T27N, R10W.
2. The applicant originally sought the approval of the Area Manager for the BLM for a standard well location in the NE/4 of said Section 26 and was denied that location.

3. As an alternative the BLM has approved the requested unorthodox location.

4. As a result of topographical restrictions and in order to obtain a drilling location for the NE/4 of said Section the applicant seeks the subject unorthodox well location.

5. Directional drilling of the subject well is not economically feasible.

6. Amoco, as the diagonally offsetting operator, has signed a written waiver of objection.

7. Meridian is the only other offsetting operator.

8. No correlative rights will be impaired by approving this application.

9. Applicant proposes to dedicate the well to the E/2 of Section 26 as described on Exhibit "A".

10. Attached as Exhibit "A" is a plat showing all of the acreage dedicated to the subject well and the surrounding acreage.


11. Attached as Exhibit "B" is a list of all offsetting owners and/or operators who are required by Division rules to receive notification of this application.

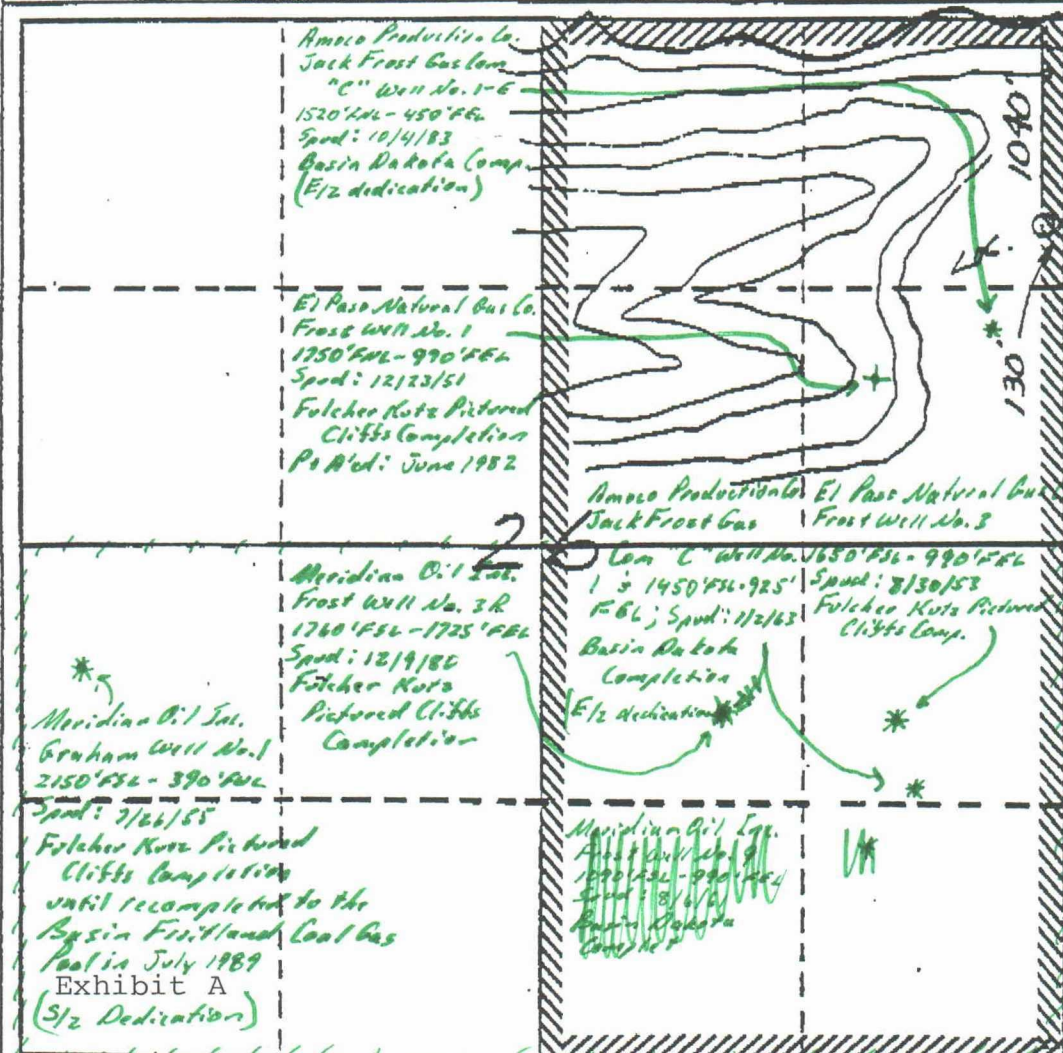

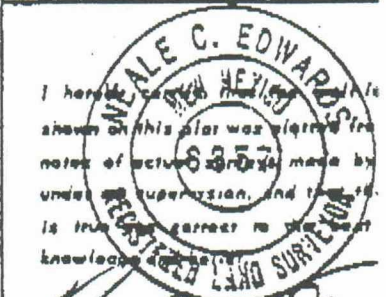
