

SUBJECT: PRODUCED WATER HAULING/DISPOSAL

DATE: November 8, 1990

During the past two weeks the Oil Conservation Division has received and investigated three reports of illegal dumping of produced water adjacent to and on lease sites in the San Juan Basin Fruitland coal gas production area. This dumping has been reported by various parties including lease operators. Unauthorized disposal of produced water is a violation of Rule 710 and subjects the violator to civil fines and criminal penalties including imprisonment. Rule 710 also provides for cancellation of transporters Form C-133, "Authorization to Move Produced Water", after notice and hearing. Accidental spills are to be reported by transporters under Rule 116.

There is growing nationwide concern over the mismanagement of oil and gas wastes, including improper transport and disposal of produced water. Some groups have proposed making some or all of these wastes subject to strict nationwide federal standards similar to the hazardous waste program. The Interstate Oil Compact Commission (IOCC), among others, believes that management of these wastes is best left to the states. It has developed technical criteria that hopefully will demonstrate to EPA and the Congress that industry and the states working together can solve waste problems without federal intervention in the form of prescriptive legislation. The IOCC technical criteria include strict waste tracking requirements which incorporate manifesting and permit requirements for water and waste haulers.

The Oil Conservation Division has thus far chosen not to implement such a system for water haulers believing it would be unnecessarily burdensome since much disposal occurs into tanks at unmanned injection well sites. However, if companies pay drivers by the number of loads transported, lack of a positive tracking system can invite abuse.

To prevent illegal dumping, OCD is requesting that transporters take the following voluntary actions:

1. Monitor closely driver transportation records to detect improper or inconsistent entries;
2. Report to OCD discrepancies in recordkeeping together with what action the company has taken to investigate possible improper disposal and to resolve the problem to prevent reoccurrence, including driver disciplinary action if warranted; and
3. Perform additional driver education on the need to follow established procedures for safe transport and proper disposal of water and other wastes.

It is the responsibility of the lease operator, transporter and disposal operator to ensure that oil and gas wastes are properly managed. Lease operators and disposal facilities (both UIC and surface disposal) are required to provide OCD with monthly reports of produced water volumes. No such reporting or other tracking procedure is currently required of transporters. To avoid adoption of additional waste tracking requirements by OCD, transporters must monitor their operations more closely and voluntarily implement the actions presented above.
