On July 1, 1980, the Commission, in Order No. R-63-68 established the Avalon-Delaware Pool. At this time, no special field rules or regulations for that pool have been established. The gas-oil ratio limitation is, therefore, set by statewide rule 506 which creates a limitation of 2,000 cubic feet of gas per barrel of oil produced.

- 3. The Applicant seeks to have established a special field rule setting the gas-oil ratio limitation for the Avalon-Delaware Pool at 7,500 cubic feet of gas per barrel of oil produced.
- 4. The approval of this application will afford Applicant the opportunity to produce its just and equitable share of gas and oil, and such amendment is feasible in accordance with good conservation practices, and will otherwise prevent waste, and protect correlative rights.

WHEREFORE, Applicant prays:

- A. That this application be set for a hearing before an examiner, and that notice of said hearing be given as required by law.
- B. That upon hearing, the Division enter its order establishing a special field rule for the Avalon-Delaware Pool setting a gas-oil ratio at 7,500 cubic feet of gas per barrel of oil produced.
- C. And for such other relief as may be just in the premises.
