- 1. Applicant is the operator of the Pennsylvanian formation underlying Section 32, Township 21 South, Range 24 East, N.M.P.M., Eddy County, New Mexico and proposes to drill the Getty IB 32 State No. 1 Well to test this formation at an unorthodox location 1320 feet from the South line and 660 feet from the West line of said Section 32.
- 2. Applicant seeks an exception to the well location requirements of the Special Pool Rules for the Indian Basin Morrow Gas Pool (Order R-2441) and the Special Pool Rules for the Indian Basin-Upper Pennsylvanian Gas Pool (Order R-2440) to permit the drilling of the Getty IB 32 State No. 1 Well at the above-mentioned unorthodox location.
