 Applicant is the operator of the W/2 of Section 10, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico.

2. Applicant proposes to dedicate the above-referenced unit to a well to be drilled at an unorthodox location 660 feet from the North and West lines of said Section 10.

3. Applicant seeks an exception to the well location requirements of Oil Conservation Division Rule 104 C II (a) to permit the drilling of a well at the above-mentioned unorthodox location to test the Pennsylvanian formation.

4. Said unorthodox gas well location will avoid the drilling of unnecessary wells, will protect correlative rights and prevent waste.
