

NOMENCLATURE ADVERTISEMENT FOR JANUARY 1985

In the matter of the application of the Oil Conservation Division of the Energy and Minerals Department upon its own motion for an order for the creation of new pools in Chaves and Eddy Counties, New Mexico, the extension of the vertical limits and redesignation of certain existing pools in Eddy County, New Mexico, and the extension of horizontal limits of certain existing pools in Chaves and Eddy Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations and extensions not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Bone Spring production and designated as the South Hackberry-Bone Spring Pool. The discovery well is Perry R.
