

This letter shall serve as the Application of Harvey E. Yates Company, Post Office Box 1933, Roswell, New Mexico 88201, for an order of the Division pooling all mineral interests from the surface to the base of the San Andres formation underlying the following described lands situated in Chaves County:

Containing 160.00 acres, more or less.

Said lands to be dedicated to four wells to be drilled thereon by applicant at standard locations, and the following owner of an undivided mineral interest thereunder has failed and refused, to date, to agree to pool its interest thereunder:

Therefore, Applicant respectfully requests the Division to enter its order:

1. Pooling all mineral interests under the above described lands from the surface to the base of the San Andres formation, to form four separate pooled units.
2. Allocating well costs.
3. Providing for supervisory charges.
4. Designating the Applicant as Operator of the pooled units.
5. Providing for an appropriate charge for risk involved in drilling of said wells.

Please set this matter for hearing on the May 8, 1985 examiner docket.
