

A P P L I C A T I O N

Comes now Pennzoil Company and applies to the Oil Conservation Division of New Mexico for an order pooling all mineral interests in the Strawn formation underlying the E/2NE/4 of Section 4, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico, for the formation of a proration and spacing unit for the said production and in support thereof would show the Commission:

1. Applicant has a right to drill and develop the E/2NE/4 of Section 4, Township 17 South, Range 37 East, NMPM.

2. Applicant proposes to drill its B. E. Shipp #2 well to be drilled 660 feet FNL and 810 feet FEL of Section 4, T17S, R37E, NMPM, to which operator will dedicate the E/2NE/4.

3. Applicant has sought to obtain the cooperation of all parties.

4. In order to obtain their just and equitable share of the production underlying the above lands,

Applicant needs an order pooling the mineral interest involved.

5. Attached as Exhibit A is a list of all working interest owners in the E/2NE/4 of said section along with their respective interests.

6. The parties names in paragraph 5 above have been furnished a copy of this application.

WHEREFORE applicant prays that this application be set for hearing before the Division's duly appointed examiner, and that after notice and hearing as required by law, the Division enter its order pooling the mineral interest described herein. Applicant further prays that it be named operator of the wells, and that the order make provisions for applicant to recover out of production its costs of drilling the subject wells, completing and equipping them, costs of operation, including costs of supervision and a risk factor in the amount of 200% for the drilling of the wells, for such other and further relief as may be proper.
