

Gentlemen:

Pennzoil Company plans to commence an 11,800' Strawn test at a legal location 660' FEL & 2130' FSL of Section 4-17S-37E, by June 1, 1985.

We request that you support said test by granting Pennzoil a Farmout Option covering the referenced lands generally along the following terms:

1. Within one hundred eighty (180) days after completion of the Initial Test Well in Section 4-17S-37E, as a producer or dry hole, Pennzoil will have the option of commencing a similar test well at a legal location on the farmout acreage.
2. Produce to earn 100% of your interest in the proration unit assigned to such well, delivering a 75% NRI lease with a 1/3 B.I. option.
3. One hundred eighty (180) day continuous drilling to earn balance of farmout acreage under same terms for optional well.
