

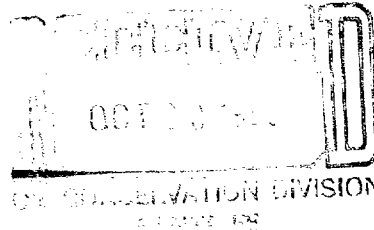

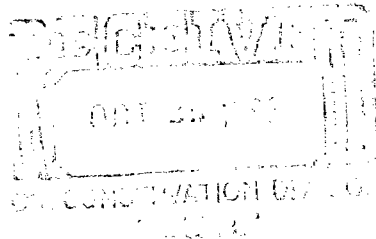

Dear Mr. Stamets:

We represent H & S Oil Company of this city, and it has furnished us with the notice of the examiner hearing on the above application to be held November 6, 1985. According to the notice, applicant seeks to pool all mineral interests from the surface to the base of the Morrow underlying the S/2 of Section 25, Township 18 South, Range 26 East, to form a standard 320-acre gas spacing and proration unit.

At the request of our client, we have recently examined title to the S/2 of Section 25, only from surface to 3,750 feet, except three tracts in the SE/4 SE/4 containing 23.32 acres, more or less. The said shallow rights working interest is presently vested in 21 parties. There are at least two producing Yeso oil wells on the lands included in the application. Although our opinion did not cover rights below 3,750 feet, the title to the leases below said depth was vested in Phillips Petroleum Company as to 1/2 and Rio Pecos Corp. and Mark D. Wilson as to 1/2.

In our examination we noted that Grynberg made some claim to United States Leases NM 54328 and NM 61328 covering 23.32 acres in the SE/4 SE/4 of Section 25. The 23.32 acres not covered by our opinion were condemned by the United States in connection with the Bureau of Reclamation's acquisition of land for the McMillan Reservoir.




Dear Mr. Stamets:
